Re: **NOTICE # 6 TO PARTICIPANTS**

TENDER NO. 51403

This notice (the "**Notice**") is being furnished to you in accordance with the provisions of Sections 11.2.4 and 11.3 of the Instructions to Bidders.

For the removal of doubt, unless otherwise explicitly stated herein, the Tender Documents remain unchanged and fully binding. It is hereby further clarified that throughout the Tender Process, ISR shall only be bound by the information submitted by it in writing, and no oral or other non-written response or information will bind ISR for any and all purposes.

Certain requests and questions received by ISR are addressed in this Notice below. ISR is still in the process of reviewing additional requests and questions submitted by Participants with respect to provisions of the Tender Documents and ISR will issue an additional Notice to Bidders with respect thereto.

Capitalized words and terms used herein and not otherwise defined shall have the same meaning ascribed to them in the Tender Documents.

1. **Question/Request:** ISR was requested to reconsider the Financial Pre-requisite regarding revenue in Section 3.3 of the Instructions to Bidders.

Answer:

- (a) The Financial Pre-requisite regarding revenue is hereby amended, such that Section 3.3 of the Instructions to Bidder shall be deleted and replaced by a new Section 3.3 as follows:

"3.3 Revenue

The weighted average annual revenue of Bidder during the Reference Fiscal Years (i.e. the WAR value as defined below) was not less than three hundred (300) Million EURO, calculated in accordance with the following formula:

$$\text{WAR}=(R_t*3+R_{t-1}*2+R_{t-2})/6$$

Where:

WAR – weighted average annual revenue.

R_t – the annual revenue of Bidder in its Financial Statements of Fiscal Year FY3.

R_{t-1} – the annual revenue of Bidder in its Financial Statements of Fiscal Year FY2.

R_{t-2} – the annual revenue of Bidder in the Financial Statements of Fiscal Year FY1."

- (b) Section 3 in Attachments C1 and D1 to the Instructions to Bidders shall be deemed amended accordingly, and the amended version of such attachments will be published by ISR in a further Notice.
2. Notwithstanding Section 9.1.2 of the Instructions to Bidders and Notice # 4, Participants are informed that ISR will not publish a translation of the Maintenance Depot Contract. Accordingly, to the extent that Participants need a translation of the Maintenance Depot Contract or any part thereof, such translation shall be prepared by Participants, for their own convenience only, and shall not be binding on ISR for any purpose whatsoever. As stated in Section 3.6 of the Agreement, the binding version of the Maintenance Depot Contract shall be the Hebrew version.
 3. The new deadline for submitting Requests for Clarifications to ISR, as per Section 11.2 of the Instructions to Bidders, is **June 14th, 2016.**
 4. Pursuant to Section 11.2.6 of the Instructions to Bidders, Participants are reminded that they shall check ISR's website on a regular basis in order to follow publications by ISR regarding the Tender, including but without limitation notices regarding Bidders' Meetings.
