**("TENDER")**

### **General Terms and Conditions**

Israel Railways Ltd. ("**ISR**"), in accordance with its obligations under the Israeli Mandatory Tender Laws, its implementing regulations and the International Agreement on Government Procurement, wishes to obtain bids for:

Professional consulting services, including but not limited to, Independent Safety Assessor (hereinafter "**ISA**"), assistance and support in order to guarantee **ISR**'s qualifications and meeting the European Regulations EC/798/2016, thereby enabling **ISR** to receive the Israeli Ministry of Transportation 's permission to operate (hereinafter: "**PTO**") several track lines (the "**Services**"), pursuant to the terms and conditions of the Agreement attached hereto, all in accordance with and subject to the terms specified in these General Terms and Conditions and the accompanying Tender Documents.

#### **1. Scope of Services**

- 1.1. The Services to be performed by the winning bidder ("**Contractor**") shall be carried out in accordance with the Scope of Services as set forth in the attached **Appendix A** and as instructed by **ISR**.
- 1.2. **ISR** may decide not to obtain all of the Scope of Services and shall be under no obligation whatsoever to obtain all or any part of the Services requested under this Tender.
- 1.3. The bidder is to submit a proposal for the requested services for the following Projects:
  - 1.3.1. Project 431
  - 1.3.2. Project Eastern Line
  - 1.3.3. Project 4<sup>th</sup> track in Ayalon

The bidder may choose to submit a bid for all three of the project listed in section 1.3, or any of the projects.

#### **2. Pre-requisites for Participation in the Tender (the "Pre-requisites")**

- 2.1. The Bidder has been accredited and is certified by the European Union Agency for Railway (EUAR) to provide a Safety Assessment Report (SAR) documents, which enables the local regulator to conclude whether or not to produce a PTO.
- 2.2. The bidder has provided Services, commencing from 2013 and onwards, for at least two projects in the field of heavy railways, with a scope of no less than two hundred and fifty (250 million Euro per project).

Definitions:

Safety Assessment Report (SAR)- Final ISA assessment of the project which is based on all the technical assessments and take into consideration the integration and operational issues. Constitute a mandatory document for the PTO.

- 2.3. It is hereby clarified that the pre-requisites are the same for all three of the projects listed in section 1.3 above.

### **3. Proof of Compliance**

- 3.1. Bidder shall prove full compliance with the Prerequisite specified in Section 2 above, by submitting to ISR all the details, documents and confirmations required under the provisions of the Prerequisites which shall include, inter alia, the following:
  - 3.1.1. Bidder shall prove its full compliance with the Prerequisite set forth in Section 2.1, by submitting a certificate certifying that it is has been accredited and is certified by the European Union Agency for Railway (EUAR) to provide a Safety Assessment Report (SAR) documents, which enables the local regulator to conclude whether or not to produce a PTO.
  - 3.1.2. Bidder shall prove its full compliance with the Prerequisite set forth in Section 02.2 by submitting a signed and completed Experience and Reference List, in the form attached hereto as **Appendix D**, evidencing that Bidder has provided Services, commencing from 2014 and onwards, for at least two projects in the field of heavy railways, with a scope of no less than four hundred (400) million Euro per project.

### **4. Location of Work**

- 4.1. The Services shall be provided as required in **Appendix A** and in the Agreement, in Israel (collectively hereinafter: the "ISR's Facilities") or in any other site, if the circumstances shall require.
- 4.2. The services shall be able to be provided, as required, in more than one site in parallel, if necessary.

## **5. Time frame for performance of Scope of Services**

5.1. The time frame for the performance of the Services shall be set out in each work package. It is hereby clarified that in the event that the timetable shall be prolonged, the Bidder shall not be entitled to any additional costs than those specified in Appendix B for the performance of Scope of Services.

5.2. **Optional Services** – ISR may ask the Bidder to perform additional services, related to the Services (“**Optional Services**”). The Optional Services shall be performed upon mutual understanding between the parties and on the basis of the rates quoted by the bidder in Appendix B.

5.3. All works, documents and or other aids produced and or used by the winning bidder while performing their obligations, shall be uploaded to an open source smart system/ data base, and ISR and all entities that take part in the ISA process shall have full access to all the documents. agreement

## **6. Governing Agreement**

The Services, including but not limited to, the price, terms of payment, scope of liability, responsibility and all other general and legal terms for the engagement with the winning bidder (the "**Supplier**"), shall be governed by the terms and conditions of the frame agreement attached hereto as Appendix C (the "**Agreement**"). The Agreement and the appendices attached thereto constitute an inseparable part of this Tender.

## **7. Price Proposal**

7.1. The total price for the Services shall be quoted by the bidder in the bidder's proposal form attached hereto as Appendix B (“**Bidder's Proposal Form**”). It is hereby clarified that all sums shall be quoted in Euro (€) currency.

7.2. The price and fees specified in the Bidder's Proposal Form (Appendix B) shall include all taxes, fees, duties, licenses, costs or other payments that are to be paid in connection with the services, including, the cost of flight tickets, transportation expenses and daily cost for board and lodging in Israel.

7.3. Furthermore, any Israeli VAT levied on the Services by the Israeli Tax Authorities shall be borne by ISR.

7.4. The price and fees specified in Appendix B shall include any sum which the Israeli Tax Authorities require to be withheld at source. The amounts required by the applicable law to be withheld at source by the Israeli Tax Authorities shall be deducted from all sums set forth above and shall be paid to the Israeli Tax Authorities.

7.5. The prices quoted in the Bidder's Proposal Form shall constitute the final, complete and inclusive price that will be paid to the Bidder for providing the

Services, including all of the related expenses and taxes, and the Bidder shall not be entitled to any other payment, fee or compensation whatsoever from ISR.

## **8. Terms of Payment**

Payment by ISR to the Supplier shall be as set forth in the Agreement.

## **9. Evaluation process and selection of Winning Proposal**

9.1. The evaluation of the bids submitted by Bidders shall be conducted by ISR in accordance with the following process:

9.1.1. **Stage A –Pre-Requisite-** Bidders will be reviewed in order to certify compliance with Section 2 above

9.1.2. **Stage A1 - Technical Evaluation** – Technical Proposals shall be evaluated in accordance with the Technical Specifications.

9.1.3. **Stage B - Commercial Evaluation** – ISR shall open the commercial proposals of Bidders who satisfied Stage A, proved compliance with all requirements of the Technical Specifications and achieved a score of at least 20 points at the TE, as detailed in Stage B above.

9.1.3.1. **Stage B1** – In the event a Bidder submits a Price Proposal for less than three projects - the prices set forth in Appendix B shall not be subjected to any price discount. In the event a Bidder submits a proposal for all three projects - All the prices submitted for each project shall be subjected to the price discount set forth in Section 8 of Appendix B.

9.1.3.2. **Stage B2** - The prices of each project that has been calculated according to Stage B1 above shall be compared. In the event that a Bidder's proposal is the lowest for all three projects, such bidder shall be selected as the winning Bidder for the project for which its proposal/s was the lowest.

9.1.3.3. **Stage B3** - In the event a Bidder's proposal is not the lowest for all three projects, the proposals shall be compared, all of which shall not be subjected to the discount. The lowest proposal, with the lowest TEP for each project shall be selected as the winning Bidder for that project. It is hereby clarified that each project shall be compared separately.

## **10. Selection of Winning Proposal**

10.1. The Winning Bidder shall be the Bidder whose proposal fully complies (and evidences compliance with) the Pre-requisites as per Section 2 above and all of the other requirements of the Tender and offers the lowest TP (total price) for the Services.

10.2. The criteria to be used by ISR for selecting the Winning Proposal shall include the Lowest TP (Total Price) for the Services as set out in Section 7 and 8 of the Bidder's Proposal Form (**Appendix B**).

$$\text{TP} = \text{SP} + \text{OP} \times 0.7$$

TP (TOTAL PRICE)

SP (SERVICES PRICE) = Project 431 + Project Eastern Line + Project 4<sup>th</sup> track in Ayalon

OP (OPTIONAL PRICE) = A1+A2+A3+B1+B2+B3+C1+C2+C3+DBL

10.4. When reviewing the proposals submitted, ISR reserves the right, in its sole discretion, to take into consideration negative past experience of ISR and/or any other entity with any particular Bidder and ISR may reject any particular proposal based solely on such past experience.

**10.4.1. – Stage C- Nomination of Conditional Winner:**

10.4.1.1. Conditional Winner shall be the Bidder whose proposal fully complies with the Prerequisites specified in Section 1 above and has the lowest TP.

**10.4.2. Stage D - Conditional Winner's Examination:**

10.4.2.1. The conditional winner shall be examined by the Israeli Ministry of Transport. ISR's representatives may, at their sole discretion, require further information from past customers in order to verify Conditional Winner's ability to perform its undertakings under the Tender.

10.4.2.2. Furthermore, the Ministry of Transport has sole discretion to decide as they see fit to approve the conditional winner or not.

10.4.2.3. The Winning Bidder shall be the Conditional Winner that receives from ISR a Winning Bidder's Notice, as detailed below.

10.4.2.4. The Winning Bidder shall be the Bidder whose proposal fully complies with the Pre-requisite specified in Section 1 above as well as the Tender's requirements, and has the lowest TEP (Total Evaluated Price), as specified in the Bidder's Proposal Form (Appendix B).

## **11. Submission of Proposals**

11.1. All proposals must be submitted no later than November 26, 2020 **by 13:00 (Israel time) ("Final Submission Date") in two separate envelopes**, as specified below, which shall read **Tender n° 41907** hereinafter: the "**Main Envelope**") at the address set forth below.

11.2. The proposal shall be submitted by a single bidder. Proposals submitted by more than one bidder will be disqualified.

11.3. The proposal is to be submitted **in 2 copies** into **Tender Box No. 8**, located at the following address:

11.4. The bidder is requested to read carefully all of the documents attached herein and submit the following documents, which should be included in the Main Envelope, signed, where applicable, by the authorized signatory bodies.

11.5. A separate envelope which shall read "**Commercial Proposal - Tender n° 41907**" shall be inserted in the Main Envelope and shall include the following:

11.5.1. A signed and completed Bidder's Proposal Form (**Appendix B**).

11.6. A separate envelope which shall read "**Pre-requisites - Tender n°41907**" shall be inserted in the Main Envelope and shall include the following technical information:

11.6.1. A signed copy of the Scope of Work (**Appendix A**)

11.6.2. A signed copy of the Agreement (**Appendix C**), including the bidder's relevant information in the heading thereof (excluding the date) and including the Bank Account Form, attached to the Agreement as **Annex C** (**only the winning bidder is required to complete part B of the Bank Account Form**).

11.6.3. List of proposed team members for the Project.

11.6.4. A signed and completed Experience and Reference List, in the forms attached hereto as **Appendix D**, evidencing compliance with the Pre-requisites as applicable.

11.6.5. C.V.'s of the proposed team members for the Project

11.6.6. Company profile of the bidder and its expertise;

11.7. In the event that ISR, for any reason whatsoever, does not enter into a contractual relationship with the winning Bidder, and/or the agreement with the winning Bidder is canceled, ISR shall be entitled to elect, as a winning proposal, the proposal which offered the next lowest price for the Services. The terms set forth in this Section shall apply, *mutatis mutandis*, following the replacement of the bidder's proposal as aforesaid.

## **12. Proposal Validity**

Bids shall remain valid for a period of six (6) months from the Final Submission Date (the "**Bid Validity Period**"), and may not be revoked or changed by the bidder during this period for any reason whatsoever.

#### **14. Verification**

ISR shall have the right, at its sole and absolute discretion, to verify the recommendations and other documents provided by the Bidder, and to request from any of the Bidders additional details, approvals, recommendations and/or certificates.

#### **15. Language of Bids**

All documents submitted by the Bidder in this Tender (including but not limited to all attachments, schedules, annexes, sketches, drawings, diagrams, tables and charts) and any additional information, question, request for clarification and interpretation, or any other communication, must be in English or Hebrew only, unless otherwise specifically stated in the Tender Documents or approved by ISR.

#### **16. General Prerogatives of ISR**

16.1. A proposal reflecting any reservation regarding the attached documents or any part thereof, including the Agreement or the appendices attached thereto, whether by rejection, insertion or amendment to any part of the attached documents, may be disqualified.

16.2. ISR shall not be bound to accept the lowest-priced proposal or any other proposal whatsoever. In addition, ISR does not commit itself in any way to acquire the Services or to enter into a contractual relationship with any of the bidders.

16.3. Any of Services provided, shall be on a non-exclusive basis and ISR at its sole discretion may at any time obtain Services from any of the bidders, and/or may acquire similar or identical Services from any third party.

16.4. The issuance by ISR of a Purchase Orders under the Agreement shall be following the receipt of the necessary budgetary approvals.

16.5. ISR, at its sole discretion, may decide not to select any of the submitted proposals or may decide to cancel the entire Tender at any time.

#### **17. Tender Procedure – General**

##### **17.1. Amendment of Tender Documents**

At any time prior to the Submission Date, ISR may amend the Tender Documents by issuing notices to the Bidders. Any notice thus issued, shall be deemed as an integral part of the Tender Documents, and shall be communicated in writing. Each bidder shall promptly acknowledge receipt of each notice to ISR (however,



each notice shall be binding upon each Bidder, regardless whether the bidder has acknowledged receipt of such notice(s) or not).

17.2. **Notification of the Winning Bidder**

ISR shall send notification of its decision to the Bidder selected as the winner in the Tender. Notification shall also be sent to the other Bidders. For the removal of doubt, the aforementioned notification of the winning bid shall not constitute the formation of a contract between ISR and the supplier, and the entering into a bidding agreement is conditioned upon the fulfillment of all required terms and conditions as detailed in the Tender Documents and the Agreement.

17.3. **Request for clarifications and/or additional information**

17.3.1. Any bidder may submit to ISR inquiries and/or requests for clarification and/or additional information regarding the Tender or relating to the Tender Documents, as specified herein below (“**Request for Clarification**”).

17.3.2. Any inquires with regards to this Tender should be addressed, by filing out the Excel document found on ISR's website titled clarifications, to Mr. Netanel Kimchi, International Procurement Coordinator, no later **September 2<sup>nd</sup>, 2020**, by e-mail: [netanelk2@rail.co.il](mailto:netanelk2@rail.co.il). Bidders shall be responsible for verifying receipt by ISR of Requests for Clarification.

16.3.3. Should ISR decide, at its sole discretion, to respond to any requests for clarifications, such response shall be published in ISR's website and, as of the date of such publication, shall constitute an integral part of the Tender Documents (each, a "**Notice to Bidders**").

16.3.4. Bidders shall be solely responsible to check ISR's website on a regular basis in order to follow publications by ISR. Any Notice to Bidders published at ISR's website shall be binding upon each bidder, whether or not bidder is aware of such Notice to Bidders, and bidders shall not have any claim in connection therewith.

16.3.5. It is hereby clarified that only information provided by ISR to the bidders by the way of a Notice to Bidders in accordance herewith shall be binding upon ISR (unless expressly specified otherwise therein), and ISR shall not be bound by any oral or written response or information communicated to Bidders in any other way.

**SCOPE OF WORK**

**General:**

ISR is interested in meeting the European Regulations EC/798/2016, therefore ISR is interested in acquiring the consulting services of an accredited railway expert in order to assist, support and provide assurances in order to guarantee that the necessary level of safety has been achieved in ISR's projects.

The Consultant is required to perform all of his assessment according to the regulation 402/2013/EC Common Safety Methods for Risk Evaluation and Assessment (CSM RA) and applicable standards EN50126, EN50128 and EN50129 by means of Audit, On-Site witness and Assessment of the necessary lifecycle documentation specifying and reporting the activities carried out by the manufacturer for the Development, Safety Verification and Validation, Installation, Testing and Commissioning for the different projects and as part of the Israeli Ministry of Transportation's (MOT) process for permission to operate (PTO).

**Required Services:**

In order to enable ISR to receive a Permission to Operate (PTO) for the different projects that are to be assessed, the following is a list of the scope of services required by the consultant:

1. Assessment activities will be performed according to the applicable standards EN50126, EN50128 and EN50129.
2. Preparing an Assessment Strategy Plan for the projects which shall include: General description of the system, scope of the assessment, general objectivities, activities and more as described in Table #1 below. The Assessment Strategy Plan shall cover all the relevant areas as requested by the project – ERW (Earth Works), CW (Civil Works), TRW (Track Works), SIG (Signalling), E&M ((Electromechanical – TVS (Tunnel Ventilation), FPW (Fire Protection Works), Emergency Systems and COMM (communication systems), ENE (Electrification), Rolling Stock (if needed) and Integration.
3. Assessing and approving the AAPP (Authority Approval Process Plan) and System Definition document.
4. The overall objectives for the assessment are Safety Management (Technical and Operational) and Quality Management Processes, which includes, but not limited to:
  - a. Review the safety management organization of the project.
  - b. Review the adequacy of the safety requirements for the design, manufacturing, installation, testing and commissioning.

- c. Assess the overall hazard identification process (PHA, ranking, mitigation, recording, monitoring and close out processes) and verify that risks have been reduced to As Low As Reasonably Practicable (ALARP);
- d. Review and assess the technical details including design documents, schematic drawings, reports, simulation results, calculations, test records, safety reports and witness testing and commissioning (including factory test, dynamic test – if relevant) to assure the safety protections undertaken for the critical subsystems and the associated interfaces are adequate;
- e. Assessment of System Safety Assurance and RAM Plan (RAMS);
- f. Evaluate the verification and validation process for handling design changes and configuration management;
- g. Evaluate and assessment of the overall T&C processes - test plans, test scenarios, test passing criteria, follow-up of test reports (FAT, SAT and SIT) and witnessing of selected equipment and system tests;
- h. Conclude the compliance with the requirements stipulated in EN 50126 “Railway applications - The specification and demonstration of Reliability, Availability, Maintainability and Safety (RAMS)”;
- i. Conclude the compliance of the safety integrity of safety related systems with EN 50128 and EN 50129 according to the Safety Integrity Level (SIL) – if relevant.
- j. Evaluate the process for managing and ensuring compliance with other relevant EN/ISR/local regulations, standards and specifications.
- k. Performing Independent Safety Audits to check that all the activities have been carried out according the Safety Plan.

6. Assessing Technical and Operational Safety Case following the principles of EN50126 and EN50129 in order to secure the PTO.
7. Proactively participate in integrated T&C processes for the project and advise different ISR departments (Operations, Maintenance, Rolling Stock, Electrification, Safety and Infrastructure) in planning for operational readiness.
8. Working closely with project managers, designers and safety experts as part of the Safety Assessment of the line.
9. The assessment will be performed development accompanying and according the project life-cycle (V-Model).
10. Managing Integration Assessment Processes for the overall project.

11. Participating in project meetings with ISR, Safety Experts Consultants, MOT and Monitoring companies, in presenting the PTO plans and maintaining confidence throughout the project phases.

General Assumptions:

- The Services shall be provided in Israel or in any other site, dependent on the particular circumstances.
- The Consultant is required to have the capabilities of providing his services in more than one site at the same time if necessary.
- Whereby a situation arises that there is additional work needed to be done which is not part of the scope of work of the project, the Consultant is responsible for contacting ISR in order to attain approval to perform the new unforeseen work. ISR stresses the fact that the consultant must receive ISR's approval before performing said services.
- The Consultant that shall provide the ISA services shall assess safety documents, provide and updated LOP (List of Open Points) until the LOP are closed or approved safety mitigation.
- ISR hereby clarifies that ISR reserves the right not to perform all or part of the work that appears in this procedure.
- The execution of the work is subject to the terms of the contract and the signed Purchase Order.

6. Bidder hereby acknowledges and declares that the Proposed Price detailed below shall also include all taxes, fees, duties, licenses, costs or other payments that are to be paid in connection with the ISA Services and additional services, including but not limited to all types of importation and custom duties and services, such as transportation costs, customs agents' fees, purchase tax (in Hebrew "Mas Kniya" or "מס קניה" ), wharfage fees (in Hebrew "Dmei Ratzif" or "דמי רציף" ), Israeli customs duties, port handling fees (in Hebrew "Dmei Nitul" or "דמי ניטול" ), port infrastructure fees (in Hebrew "Dmei Tashtit" or "דמי תשתית" ), cleaning of the containers, stuffing and unloading of the containers, cam locks for discharging the MSRS and/or any Additional MSRS at port, supervision while discharging at port, discharging terms at port, etc. For the sake of clarity, the Prices shall include any sum which the Israeli Tax Authorities require to be withheld at source.
